Krystsina Tsimanouskaya

Krystsina Tsimanouskaya, an Olympian from Belarus now representing Poland, advocates for human rights and freedoms following her repression during the Tokyo Olympics in 2020. To avoid political persecution, she received the foundation's help to safely relocate.

Andrei Krauchanka

Andrei Krauchanka, an Olympic medal winner, and celebrated decathlete, faced severe repression for his activism during the 2020 protests in Belarus and was jailed for taking part in peaceful protests. He remains a dedicated advocate for freedom and human rights.

Aliaksandr Apeikin

Aliaksandr Apeikin is a political scientist and former handball club owner who founded the Belarusian Sports Solidarity Foundation in response to the 2020 mass repression in Belarus. He received a 12-year in-absentia sentence for supporting democracy.

Scott Goodstein

Scott Goodstein, digital communications strategist for over 20 years, led Obama's 2008 and Sanders's 2016 digital campaigns; founder of Catalyst Campaigns.

Konstantin Yakovlev

Konstantin Yakovlev, ex-handball professional player and coach, now advocates for human rights, promoting equality, justice, and fundamental freedoms worldwide.

Andrey Morozov

Andrey Morozov is a seasoned sports journalist, TV presenter, and high-level fencer who advocates for democratic values and free speech.

Andrei Chepa

Andrei Chepa, a seasoned lawyer, resigned from his roles in sports administration in protest against the fraudulent Belarusian elections, demonstrating his dedication to democracy and human rights. He had to flee his homeland to avoid persecution.
